And whereas it has become necessary to declare the objects and terms above: of the public charitable and educational trust.

Now this deed of declaration of Charitable Trust witnesseth as under:

- TRUST and 1. This Trust shall be known as P.A CHARITABLE its office shall be for the present at 72/BC 59, Elango Street, Mahalingapuram, Pollachi - 642 002.
- THE OBJECTS AND PURPOSE OF THE TRUST ARE AS UNDER:
 - a) To run and maintain schools, colleges, educational institutions, hospitals in healthy and elobouratious surroundings and educate the poor and down - trodden children.
 - b) To run home for residence and welfare of the senior citizens.
 - c) To provide shelter, clothing, food, education and medicines to the poor and needy.
 - d) To construct Hostels and to provide free accommodation and assistance to the poor students.
 - e) To establish, maintain and run homes for orphanage children and to give food, cloth, medicines, education and recreation to them.

- To carry on community development programmes for the uplishment of economically weaker sections of the society and also construct and develop community center or halls for carrying on such activities.
- g) To open establish, construct, maintain, run, aid, develop, improve and extend hospitals, dispensaries, maternity home, child welfare centre and other centers for rendering medical aid / medical socia services in any of the systems viz Allopathy, Siddha, Ayurvedha, Nature cure, Homeopathy, Yoga, Therapy, Acupunture and any other systems of medicine and run institution for improving the health of the public and prevention of diseases and provide free medicines and medical advises.
- h) To open, run, assist or aid research centers and institutions for promotion of research and education for medical science including surgery.
- i) To conduct free eye camps for the use and benefits of suffering people and to propagate eye donation by running camps, publication of books, pamphlets and periodicals.
- j) To found, construct, takeover, own, subsidise, help and make donations to educational, vecational and medical institutions, recreational centres for disabled, crippled, blind, deaf, dumb, mentally retarded or otherwise handicapped children and adults and to develop their health, character and vocational pursuits.

- 9. The Managing Trustee shall hold office for his lifetime. Subsequently his younger daughter A. Kalaivani shall automatically become the Managing Trustee.
- 10. The trust may accept gift of money or movable or immovable property from author or any other persons on such terms and conditions as may b deemed profit in the augmentation of the trust fund and all the provisions contained in this trust deed shall be applicable thereto as of such money or property had formed part of the original trust fund.
 - 11. The trustees shall invest the properties and moneys of the trust in such manner as per the Income Tax Act, 1961.
 - 12. The Board of trustees shall meet as often as necessary and their proceedings shall be recorded regularly in the minutes book to be retained for the purpose. If any resolution to be passed touching the administration of the trust the opinion of the majority shall prevail.
 - 13 The trustees may by resolution extend the activities of the trust or undertake any activity infurtherance of the main objects of the trust.
 - 14. The trustees can do any other lawful things as are incidental in carrying out the administration and management of the trust.

- 15. The trustees may frame rules and regulations as to the duties and responsibilities of each trustee, to appoint sub committees, made a conducting any other matters connected with the administration of the trust and management.
- 16. The trustees can raise funds by carrying on any activity for carrying out the objects of the trust.
- 17. The trustees may open and operate saving or current or deposit or other accounts with any Nationalised or Scheduled Bank or Banks and the account may be operated by Sri.P.Appukutty and Smt.Lakshmi Appukutty either Individually or Jointly.
 - 18. The trustees shall keep and maintain proper books of accounts regularly and the same shall be closed on 31st March of every English calendaryear. The accounts of the trust shall be audited by a qualified chartered accountant every year.
 - 19.For the purpose of the objects of the trust, the trust can purchase, take on lease or otherwise acquire land, construct building and establish machinery, tools and implements and also accept movable or immovable properties from any other trust with same objects.
 - 20. The Board of Trustees can sell, if needed any property of the trust provided the trustees unanimously agree for such sale and to authorise Managing Trustee to sign and execute necessary instruments and documents required therefore.

- 21. The Trustees shall not be entitled to any remuneration and shall work in an honourary capacity. They shall however be entitled to receive the out of pocket expenses incurred by them in the course of discharging.
- 22. The trustees can purchase or otherwise acquire stocks, shares, debentures, annuities and securities of every other description for the benefit of the trust.
- 23.To institute, prosecute, defend and compromise all actions and proceedings before the Government courts, tribunal authorities including suits, appeals, reviews, revisions, executions and the like and to represents the trust before.
- 24. To enter into any compromise and to refer the matter for arbitration.
- 25.To engage the services of any person or persons upon such remuneration and terms as the trustee may deem fit and to take disciplinary action against them and also terminate their services.
- 26. To be a beneficiary under any other trust or trusts.
- 27. The trustees shall not be liable for any loss that may be caused to the trust fund unless the trustees are found guilty or fraud or criminal breach of trust by a competent court of law, likewise the liabilities of the trust shall not affect the private assets of the trustees.

- 29.It is declared that the trust is irrecoverable. If the trust fails for any reasons, in the opinion of the trustees the net assets of the trust both movable and immovable shall be handed over to any other trust having the same objects as decided by the majority of the trustees.
- 30. The income and funds of the trust will be utilised towards the objects and no portion of it will be utilised for payment to trustees / members by way of profit, interest, dividend, etc.,
- 31. Any amendment to the trust deed, bye laws will be carried only with th approval of Commissioner of Income Tax.
- 32. No activities of the trust shall be carried outside India.
- 33. The Trust is IRREVOCABLE
- 34 There is no movable or immovable property as on the date of this Tru Deed in the name of the Trust.




