And whereas it has become necessary to declare the objects and terms of the public charitable and educational trust.

Now this deed of declaration of Charitable Trust witnesseth as under :

1. This Trust shall be known as **P.A CHARITABLE TRUST** and its office shall be for the present at **72/BC 59, Elango Street, Mahalingapuram, Pollachi - 642 002.**

2. THE OBJECTS AND PURPOSE OF THE TRUST ARE AS UNDER :

- a) To run and maintain schools, colleges, educational institutions, hospitals in healthy and elobourations surroundings and educate the poor and down - trodden children.
- b) To run home for residence and welfare of the senior citizens.
- c) To provide shelter, clothing, food, education and medicines to the poor and needy.
- d) To construct Hostels and to provide free accommodation and assistance to the poor students.
- e) To establish, maintain and run homes for orphanage children and to give food, cloth, medicines, education and recreation to them.

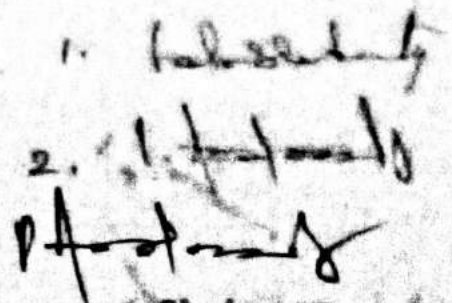

- (i) To train and equip pupils so as to be self supporting in an honourable and decent way of life so as to develop into good healthy and progressive citizens.

3. The First Trustee of the Trust shall be :

a) Sri.P.Appukutty S/o.Palanisamy 72/BC 59 Elango Street, Mhalingapuram, Pollachi - 642 002 Managing Trustee.

b) Smt.Lakshmi Appukutty W/o.Appukutty 72/BC 59 Elango Street, Mhalingapuram, Pollachi - 642 002 Trustee and Founder Trustee.

4. Sri.P.Appukutty shall be designated as the Managing Trustee who shall be incharge of the day to day affairs of the trust.

5. The Managing Trustee is empowered to co - opt. More trustees for the trust and fix the terms of their appointment.

6. The trust shall be for the benefit of all general public belonging to whatever community irrespective of caste, creed or religion.

7. The objects of the trust will not include objects involving the carrying on of any activity for profit within the meaning of the Income Tax Act,

8. The Managing Trustee shall receive income, interest, rent, dividends and other income for the trust fund and pay all costs, charges and expenses incidental to the management, administration and to the execution of the trust and the power thereof.

9. The Managing Trustee shall hold office for his lifetime. Subsequently his younger daughter A. Kalaivani shall automatically become the Managing Trustee.

10. The trust may accept gift of money or movable or immovable property from author or any other persons on such terms and conditions as may be deemed profit in the augmentation of the trust fund and all the provisions contained in this trust deed shall be applicable thereto as of such money or property had formed part of the original trust fund.

11. The trustees shall invest the properties and moneys of the trust in such manner as per the Income Tax Act, 1961.

12. The Board of trustees shall meet as often as necessary and their proceedings shall be recorded regularly in the minutes book to be retained for the purpose. If any resolution to be passed touching the administration of the trust the opinion of the majority shall prevail.

13. The trustees may by resolution extend the activities of the trust or undertake any activity in furtherance of the main objects of the trust.

14. The trustees can do any other lawful things as are incidental in carrying out the administration and management of the trust.

15. The trustees may frame rules and regulations as to the duties and responsibilities of each trustee, to appoint sub committees, mode of conducting any other matters connected with the administration of the trust and management.

16. The trustees can raise funds by carrying on any activity for carrying out the objects of the trust.

17. The trustees may open and operate saving or current or deposit or other accounts with any Nationalised or Scheduled Bank or Banks and the account may be operated by Sri.P.Appukutty and Smt.Lakshmi Appukutty either Individually or Jointly.

18. The trustees shall keep and maintain proper books of accounts regularly and the same shall be closed on 31st March of every English calendar year. The accounts of the trust shall be audited by a qualified chartered accountant every year.

19. For the purpose of the objects of the trust, the trust can purchase, take on lease or otherwise acquire land, construct building and establish machinery, tools and implements and also accept movable or immovable properties from any other trust with same objects.

20. The Board of Trustees can sell, if needed any property of the trust provided the trustees unanimously agree for such sale and to authorise Managing Trustee to sign and execute necessary instruments and documents required therefore.

21. The Trustees shall not be entitled to any remuneration and shall work in an honorary capacity. They shall however be entitled to receive the out of pocket expenses incurred by them in the course of discharging.

22. The trustees can purchase or otherwise acquire stocks, shares, debentures, annuities and securities of every other description for the benefit of the trust.

23. To institute, prosecute, defend and compromise all actions and proceedings before the Government courts, tribunal authorities including suits, appeals, reviews, revisions, executions and the like and to represent the trust before.

24. To enter into any compromise and to refer the matter for arbitration.

25. To engage the services of any person or persons upon such remuneration and terms as the trustee may deem fit and to take disciplinary action against them and also terminate their services.

26. To be a beneficiary under any other trust or trusts.

27. The trustees shall not be liable for any loss that may be caused to the trust fund unless the trustees are found guilty of fraud or criminal breach of trust by a competent court of law, likewise the liabilities of the trust shall not affect the private assets of the trustees.

28. Every trustee for the time being shall be indemnified out of the assets of the trust fund against any liability incurred by her in the proceedings either civil or criminal in which the judgement is given in her favour or in which she is acquitted provided the said proceedings relate to an matter arising out of the administration of any act lawfully and bonafide done by his as trustee.

29. It is declared that the trust is irrecoverable. If the trust fails for any reasons, in the opinion of the trustees the net assets of the trust both movable and immovable shall be handed over to any other trust having the same objects as decided by the majority of the trustees.

30. The income and funds of the trust will be utilised towards the objects and no portion of it will be utilised for payment to trustees / members by way of profit, interest, dividend, etc.,

31. Any amendment to the trust deed, bye - laws will be carried only with the approval of Commissioner of Income Tax.

32. No activities of the trust shall be carried outside India.

33. The Trust is IRREVOCABLE

34. There is no movable or immovable property as on the date of this Trust Deed in the name of the Trust.


